Mayor Hulslander appointed an SOP Committee.

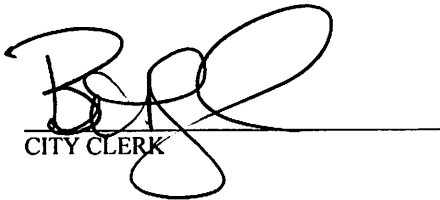

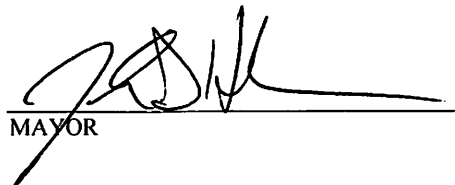
The Council discussed a house number awareness outreach program.
