Council discussed Revolving Loan Fund.

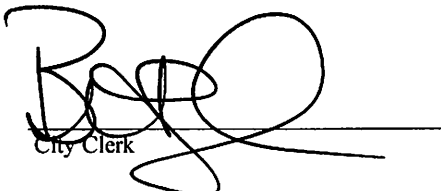

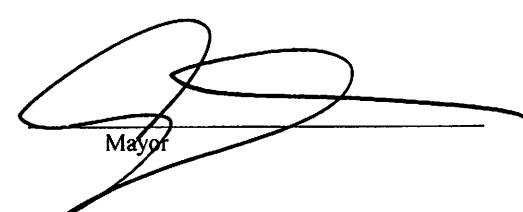
Johns made a Motion to accept the Annual Raises for City of Elmwood Employees. Strom 2nd the Motion. All agreed. Motion carried.
